Executive Summary

Liza is a Chartered Accountant (CA(SA)) with 23 years' experience in the financial services industry. Her experience ranges from enterprise wide risk management, credit approval for lending to SME's, to project finance, and for the last 10 years she has been specialising in Risk Finance (self-insurance, cell captive and UMA's) environment. Her last position in corporate environment prior to entering the consulting space in 2019, was that of MD of a short-term insurance cell captive licence with a turnover of R2.7bn in gross written premium. She has experience in managing teams of people with varied specialities and experience. She is both strategically minded, but practical in the application and implementation of systems and processes.
